- Branded Fares are only valid via DL, DL Connection and DL applicable codeshare flights (006 code).
- Administrative fees for published fares and zones fares are subject to change.
- As used in this Agreement, the following terms have the following meanings:

"Branded Fare" means each of the names given by Delta to products that includes specific amenities and services assigned to the corresponding fare to facilitate customer choice and create an overall customer experience. Branded Fares are subject to change from time to time. Existing Branded Fare may be repurposed, renamed, or retired, and new Branded Fares may be introduced, in each case upon notice.

"Delta Main Basic" means a Delta Branded Fare that (i) is a generally lower-priced version of Main Cabin, and (ii) does not include all the services and amenities of Main Cabin. As of the effective date of this Agreement, Delta Main Basic (or any equivalent successor Branded Fare thereof) has a ticketed class of service of E, as may be adjusted from time to time by Delta in its sole discretion upon notice.

"Comfort+" means a Delta Branded Fare that (i) has seat locations exclusive from the seats available to Delta Main Basic or Main Cabin, and (ii) has services or amenities that differentiate the Delta Branded Fare as an elevated product compared to Main Cabin. As of the effective date of this Agreement, Comfort+ has a ticketed class of W or S, as may be adjusted from time to time by Delta in its sole discretion upon notice.

"Delta One" means a Delta Branded Fare that (i) has seat locations exclusive from the seats available to Delta Main Basic, Main Cabin, Comfort+, Delta Premium Select, or First Class, and (ii) has services or amenities that differentiate the Delta Branded Fare as an elevated product compared to First Class. As of the effective date of this Agreement, Delta One has a

ticketed class of J, C, D, I, or Z as may be adjusted from time to time by Delta in its sole discretion upon notice.

“Delta Premium Select” means a Delta Branded Fare that (i) has seat locations exclusive from the seats available to Delta Main Basic, Main Cabin, or Comfort+, and (ii) has services or amenities that differentiate the Delta Branded Fare as an elevated product compared to Comfort+. As of the effective date of this Agreement, Delta Premium Select has a ticketed class of P, A, or G, as may be adjusted from time to time by Delta in its sole discretion.

“First Class” means a Delta Branded Fare that (i) has seat locations exclusive from the seats available to Delta Main Basic, Main Cabin, Comfort+, or Delta Premium Select, and (ii) has services or amenities that differentiate the Delta Branded Fare as an elevated product compared to Delta Premium Select. As of the effective date of this Agreement, First Class has a ticketed class of F, as may be adjusted from time to time by Delta in its sole discretion upon notice.

“Main Cabin” means a Delta Branded Fare that (i) has the same seat location as Delta Main Basic, and (ii) has services or amenities that differentiate the Delta Branded Fare as an elevated product compared to Delta Main Basic. As of the Effective Date, Main Cabin has a ticketed class of service of Y, B, M, H, Q, K, L, U, T, X, or V, as may be adjusted from time to time by Delta in its sole discretion upon notice.

Reservations and Ticketing

- Must adhere to TSA regulations and Secure Flight Passenger Data guidelines.
- Miles may be earned on certain purchased Branded Fares, excluding, as of the effective date of this Agreement, Delta Main Basic. For more information how to earn miles on eligible Branded Fares and up-to-date Branded Fare eligibility, please visit <https://www.delta.com/us/en/skymiles/program-resources/program-rules>. Branded Fare rules apply. Miles travel award redemptions are not permitted with use of the offers under this Agreement.
- Meeting Ticket Designator/Meeting Code to be provided upon acceptance of this Agreement. For meeting agreements, please allow up to five (5) business days for receipt of Meeting Ticket Designator/Meeting Code.
- Tickets must be issued on 006 ticket stock and reflect the applicable Branded Fare basis and Meeting code.
- Once ticketed, if changes occur, an administrative fee may apply in addition to any difference in the Branded Fare.
- Reservations and ticketing are available via www.delta.com by entering your Meeting Code under the “Advanced Search” option or by calling our Conferences and Events Reservations at 800-328-1111.

Incentives and Awards

- Delta shall provide the organization with two (2) \$250 (\$500 in total) earned Travel Credit Vouchers (“TCV”) for every 50 round-trip tickets purchased and flown in accordance with this Agreement and the SkyMiles Membership Guide and Program Rules.
- The number of TCVs earned will be determined based on the number of roundtrip tickets flown and NOT the number of tickets issued.
- Each earned TCV will be issued for travel on Deltamarketed flights operated by DL, 9E, AF, AM, KE, KL, LA, OO, VS, YX
- Earned TCV, will be provided within 12 weeks of the expiration date of this Agreement and are subject to private booking inventory.

Terms and Conditions

All updates to this Agreement must be done through your contract owner or Delta Air Lines.

- Use of Branded Fares provided pursuant to this Agreement by anyone other than the applicable named party is strictly prohibited.
- This Agreement may not be assigned, transferred or otherwise conveyed to any third party without the prior written consent of Delta.
- Modifications or amendments of this Agreement are not permitted without the prior written consent of Delta. This Agreement may be cancelled by Delta at any time, with or without cause, upon written notice to the other party. Any

tickets purchased pursuant to this Agreement prior to its cancellation will be honored.

- In the event of a breach of this Agreement by a party, this Agreement may be terminated by the non-breaching party immediately upon written notice to the other party, in addition to any other rights and remedies the non-breaching party may have.
- This Agreement is conditioned upon a minimum purchase of 50 round-trip tickets AND such tickets being flown on eligible flights.
- All promotional materials, including print and online, that include Delta's name or any of Delta's trademarks, service marks or trade name or other intellectual property must be provided and approved in advance by Delta. All such uses of any Delta intellectual property must be removed no later than three (3) days after the event or meeting.
- Delta will not be liable for flight delays or cancellations. Delta reserves the right to change equipment or schedules without notice.
- All transportation is subject to Delta's contract of carriage and applicable tariffs.
- This Agreement and the terms and conditions hereof, are confidential and shall not be disclosed by the customer to any third party, including without limitation, any travel agency or consolidator.
- Customer is fully responsible for ensuring that any person contracted on its behalf adheres to all terms and conditions of this Agreement. Violation of any term of this Agreement by the customer or any agency/person contracted on its behalf may, among other things, result in the following: termination of the Agreement, debit memo issued against customer or any agency/person contracted on its behalf for the difference in the fare between the ticket issued improperly and the appropriate valid retail fare and legal action against customer or any agency/person contracted on its behalf for damages suffered by Delta, including any lost profits.

Delta may terminate this Agreement effective immediately upon written notice to customer if Delta determines, in its sole discretion, customer is involved or associated, directly or indirectly, with any activity that could negatively affect the goodwill or reputation of Delta or that disparages or brings Delta into disrepute.

Block Space GUIDELINES
